Hi Ken,

Please take a look at these sampling points I am suggesting for the UMAM. I took into consideration the different wetland types, however, if a wetland was too large and with no significant differences I only chose one location within it. Another approach could be to locate UMAM sampling points on those large wetlands at certain intervals.

There are 24 points, but more could be added if needed. I did not include river/canals crossings, given that there will be no impacts, I am correct?

I am taking a look at Cano Tiburones to pre-select suitable areas for mitigation purposes.
